We request that you immediately remove the pictures, names and comments of the relevant current and former CBA and Bankwest employees from the above website and any other social media platforms and forums. We also request that you refrain from making such references in the future.

Please acknowledge receipt of this letter and confirm that you will immediately remove the material relating to CBA and Bankwest's current and former employees from the above website.
