I refer to your recent correspondence requesting a summary of the fees and costs incurred by myself and lan Francis (together, the "Receivers") in respect of the receiverships of the Companies.

As previously advised, information pertaining to the costs of the receiverships of the Companies is made available when the Receivers lodge the mandatory Forms 524 with the Australian Securities and Investments Commission ("ASIC"). The most recent Forms 524 in respect of the Companies were lodged with ASIC on or about 17 February 2012. The Receivers are otherwise under no obligation to provide you with the requested information.

Notwithstanding the above, and in the interests of transparency and correcting certain inaccurate statements and allegations in your correspondence, we provide the following summary of the fees and disbursements properly incurred by the Receivers in respect of each receivership as at 30 April 2012 (excluding legal fees) (including GST and disbursements):
